§1.

1. The Ordering Party orders and the Contractor accepts to perform the order of child transportation service:

2. The Contractor undertakes to perform the service referred to in section 1 point 1 in the period from September 03, 2021 to June 30, 2022.

3. By providing the service it is understood to ensure the transportation of a child to:

4. Payment shall be made in two installments: **50 %** of the amount until September 2 2021 and another **50 %** until January 30, 2022 by bank transfer to the following account No.: 07 1160 2202 0000 0001 7362 3112.

5. The remuneration referred to in point 4 covers all risk and liability of the Contractor for correct estimation of all costs related to the performance of the subject of the order.

§2.

1. The Contractor is responsible for the technical efficiency of vehicles in accordance with the technical conditions specified for a given type of vehicle and for having current technical inspections of the vehicle for the purpose of transporting children.

2. The transportation will be performed by buses adapted to transport children in accordance with applicable regulations.

3. The Contractor shall ensure that children are transported by drivers who have the appropriate, legal rights to transport persons.

4. Prior to entering the school bus, each child will have temperature measured and will be required to disinfect hands. The children with the temperature over 37,7°C will not be allowed to enter the bus.

5. Driver and child minder will be using face masks.

6. In performing this Contract the Contractor must comply with the provisions of the "Road Traffic Law", "Transport Law" and other applicable laws. In particular, the Contractor undertakes to maintain adequate civil liability insurance throughout the duration of the Contract.

7. The Contractor undertakes to provide a substitute means of transportation for children meeting the requirements specified by law, in the event of vehicle breakdown and other random causes.

§3.

1. Any disputes arising from the performance of the subject of the agreement shall be submitted by the parties to the competent District Court.
