After the time group leaves the school and the bus leaves. The exception is pre-school children who are brought to the point by the guardian.**

→ **We do not take responsibility for items left on the bus.**

→ **The Contractor provides parents with access to a mobile application through which they can track the current location of the bus.**

4. Payment (100% of the year cost) must be made before **September 3rd, 2024** by bank transfer to the following account: **07 1160 2202 0000 0001 7362 3112**. In the title of the transfer, please indicate the surname and first name of the child. Confirmation should be sent to **biuro@monsters.com.pl**

5. We will provide transport service to the child only after the contract has been 100% paid and a confirmation of it is sent to the e-mail address indicated in the previous point.

6. The remuneration referred to in point 4 covers all risk and liability of the Contractor for correct estimation of all costs related to the performance of the subject of the order.

§2

1. The Contractor is responsible for the technical efficiency of vehicles in accordance with the technical conditions specified for a given type of vehicle and for having current technical inspections of the vehicle for the purpose of transporting children.
2. The transportation will be performed by buses adapted to transport children in accordance with applicable regulations.
3. The Contractor shall ensure that children are transported by drivers who have the appropriate, legal rights to transport persons.
4. In performing this Contract the Contractor must comply with the provisions of the "Road Traffic Law", "Transport Law" and other applicable laws. In particular, the Contractor undertakes to maintain adequate civil liability insurance throughout the duration of the Contract.
5. The Contractor undertakes to provide a substitute means of transportation for children meeting the requirements specified by law, in the event of vehicle breakdown and other random causes.

§3

1. Any disputes arising from the performance of the subject of the agreement shall be submitted by the parties to the competent District Court.
